We will be working hard over the next few months to get the sixth floor ready for us - check back in Spring 2023 for an update on our anticipated move-in date!



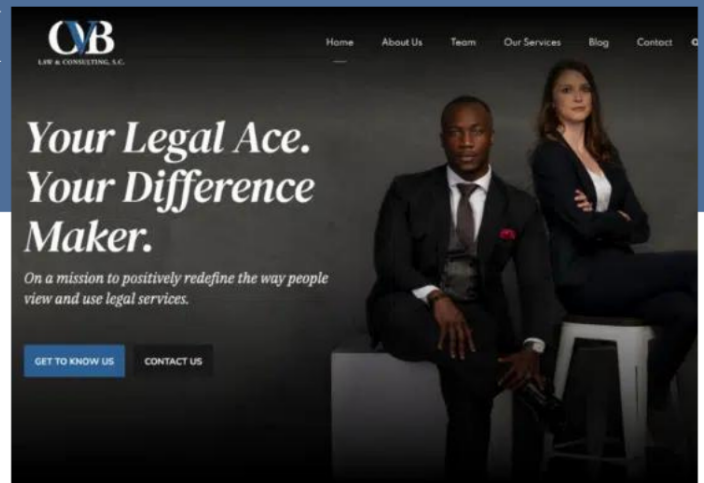
